

Safeguarding at Derby Cathedral

- 1. At its meeting of 27th February 2025, the Chapter of Derby Cathedral reaffirmed its commitment to the six overarching safeguarding policy commitments of the Church of England, as set out in *Promoting a Safer Church*, namely:
 - i. Promoting a Safer environment and culture;
 - ii. Safely recruiting and supporting all those with any responsibility related to children, young people and vulnerable adults within the Church;
 - iii. Responding promptly to every safeguarding concern or allegation;
 - iv. Caring pastorally for victims/survivors of abuse and other affected persons;
 - v. Caring pastorally for those who are the subject of concerns or allegations of abuse and other affected persons;
 - vi. Responding to those that may pose a present risk to others.
- 2. The Chapter re-adopted the Safeguarding Policy of the Church of England.
- 3. The Chapter re-adopted the following pieces of Practice Guidance for Derby Cathedral:
 - a. Management of Offenders and those whose behaviour poses a risk to others.
 - b. Practice Guidance on Choir visits (previously Choir Tours).
 - c. Safeguarding Policies on visiting musicians
 - d. Safeguarding Policies on Cathedral Lay Clerks and Deputy Lay Clerks
 - e. Whistleblowing Policy
- 4. The Chapter appointed/re-appointed the following to particular roles in the Cathedral:
 - a. Chair of Safeguarding Committee David Legh
 - b. Cathedral Safeguarding Lead The Venerable Matthew Trick
 - c. Cathedral Safeguarding Ambassador Peter Harrison
 - d. It was agreed that, in addition, other members of the Safeguarding Committee should be:

Dean (ex officio) The Very Revd Dr Peter Robinson

Cathedral Chief Operating Officer Carol Thomas
Head of Operations Jessica Kilmurray

The Chapter re-adopted the remit of the Safeguarding Committee:

To meet at least quarterly:

- a) Devising policies and procedures for Chapter approval
- b) Overseeing the day to day operation and monitoring of such policies and procedures
- c) Ensuring that appropriate vetting and training of volunteers and staff takes place
- d) Monitoring the care of children & young people and vulnerable adults
- e) Monitoring the oversight of offenders
- f) Creating a culture of informed vigilance
- g) Ensuring that any necessary action is taken swiftly
- h) Reporting to Chapter on a regular basis
